Objectives of this engagement

MRSB Consulting Services was engaged to work with the Partnership for Growth (PFG) to:

- Design and implement a consultation process and secondary research
- Develop an action-oriented Economic Action Plan with a long-term vision (PFG) and 5-year actions
- Evaluation and Monitoring Framework

The consultation process to-date included more than 200 stakeholders, including:

- PFG Founding Partners
- Industry representatives from various sectors, stages of business, and geographic areas
- Business, industry and community organizations
- Post-secondary institutions and youth
- First Nations and Francophone communities
- Municipal, provincial, and federal governments
- Extensive secondary research and observations by consultants



2020 Impact and Outlook

PEI has experienced
12 consecutive years of
strong economic growth,
with the two most recent
years involving the highest
growth rate among
Canadian provinces.

Our record of sustained economic growth was disrupted in March 2020 with the global pandemic, resulting in a public health and economic crisis.




Figure 1: PEI led among all Canadian provinces in GDP growth in 2018 and 2019.




Figure 2: PEI's GDP grew 16.3% over the last 5 years, exceeding all other provinces and national average of 9.2%.




Figure 3: PEI led the country in population growth in each of the last four years.




Figure 4: PEI's 5-year population growth has outpaced all other provinces and national average.

Impact of COVID-19 on PEI Sectors

SEVERE IMPACT

Tourism and hospitality, including restaurants, bars and accommodations (new business/delivery models, delayed opening, limited capacity)

Sporting, tourism, cultural and recreational activities (delayed opening, travel restrictions)

Retail (with the exception of grocery stores and online/curbside pick-up)

Aerospace (focus on maintenance and overhaul)

MAJOR IMPACT

Agriculture, including potato processing (reduced demand by restaurants and fast food chains)

Construction industry (delayed capital projects)

Fisheries, aquaculture and seafood processing (reduced demand by restaurants and fast food chains)

Transport (passenger transport hit hard, cargo down)

Wholesale (supply chain management)

Other services

MODERATE IMPACT

Advanced manufacturing (continued demand and shift to COVID-19 products)

Education (home schooling and online delivery models)

Food processing (business disruption)

Bioscience (continued demand and shift to COVID-19 products)





Create an Outstanding Environment where Businesses and Communities Can Thrive

1A. Connect every person, business, and community to economic opportunity through reliable high-speed internet access

1. Accelerate investment in reliable and consistent access to high-speed internet across the province – this is essential to economic recovery and growth and to support entrepreneurial activity, attraction of talent and businesses, and building resilient communities

1B. Create a more competitive environment for doing business

- 1. Conduct a comprehensive review of PEI's tax system to support competitive prospecting and retention strategies —PEI has one of the highest tax rates among Canadian provinces
- 2. Streamline the offering of adaptable and flexible provincial government programs to enable business growth
- 3. Advocate for PEI or Atlantic Canada solutions that address barriers to doing business and pursuing opportunities
- 4. Enable entrepreneurship in PEI through public procurement, outsourcing, and service delivery arrangements in collaboration with the private sector

1C. Build thriving communities where people want to live and work

- Develop and implement an industry-led tourism strategy focused on collaboration to grow higher yield markets and to build confidence in tourism in PEI by the public and visitors
- 2. Invest in vibrant community hubs that revitalize and grow communities and attract people and businesses
- 3. Promote and support integrated community planning that incorporates economic, social, and environmental criteria and identifies linkages and shared services with surrounding urban and rural areas
- 4. Access support for innovative business and community-led solutions to address affordable housing, transportation, and childcare needs in rural and urban communities



Develop a Growing, Diverse and Skilled Workforce Necessary for PEI's Economic Future

2A. Prepare the workforce for the future

- 1. Establish sector-specific approaches to workforce development to address skills and labour gaps
- 2. Enhance and develop flexible and adaptable delivery models within a post-secondary education environment that recognizes the evolving needs of learners and businesses
- 3. Enhance customized supports for retraining and reskilling, as technology changes the nature of the work across sectors

2B. Create pathways to employment and entrepreneurship for youth

- 1. Promote private sector involvement in experiential learning through K-12 and post-secondary education
- 2. Improve K-12 outcomes to ensure excellence in student achievement and prepare students for the future
- 3. Develop seamless pathways for international students to access employment and become permanent residents, bringing together key stakeholders to define and implement priorities

2C. Attract people to live in PEI (immigrants, other Canadians, expatriates)

- 1. Revisit PEI's population growth strategy, including recruitment, integration, and retention
- 2. Explore and develop opportunities for an immigrant program that supports employment and investment, and addresses the need to grow and diversify PEI's population
- 3. Access help to attract skilled foreign workers through a long-term commitment to an enhanced Atlantic Immigration Pilot
- 4. Host a roundtable on inclusive and welcoming communities to share best practices and define collaborative approaches to embrace diversity

2D. Promote and support healthy, diverse, and inclusive workplaces

1. Provide professional development opportunities for employers, and explore the potential for employer certification or recognition for training (e.g., mental health, inclusivity and diversity)



Stimulate Innovation and Sector by Sector Growth in a Changing Global Environment

3.A Boldly support and invest in high-growth sectors

- 1. Access provincial and federal government funds to support cluster-identified priorities, including strategic infrastructure investments building on the successful BioAlliance PEI Bioscience Cluster model
- 2. Pursue the next level of growth for value-added food, leveraging PEI's quality agriculture, fisheries, and aquaculture and reputation as Canada's Food Island
- 3. Establish industry-led leadership and cluster development for ICT, mapping strategic areas of growth for urban and rural PEI
- 4. Build coordinated leadership and supportive ecosystem to fully realize the growth potential of PEI's gaming industry
- 5. Renew the prospecting strategy to build on the competitive advantage of PEI's location in a post-COVID world, working with cluster hubs to collaboratively pursue growth targets

3.B Diversify our economy to grow our exports

- 1. Transform to a digital economy. PEI's future competitiveness and growth prospects are linked to our ability to seize opportunities created in the rapidly evolving digital economy (e.g., supports for ecommerce and to redefine business models)
- 2. Build a leading cleantech cluster, accelerating R&D, innovation, exports, and cross-sector collaborative initiatives

3.C Strengthen the competitiveness of PEI industries

- 1. Ensure every industry/sector has a strategy that aligns with the priorities of this economic action plan
- 2. Accelerate investment in automation, artificial intelligence, and equipment to support productivity improvement at levels that recognize the different scale of investment required for specific sectors and businesses
- 3. Provide opportunities for real-life testing of private sector innovation (goods and services) within government

3.D Accelerate research and development that will lead to innovation

- 1. Advance R&D to support industry-driven priorities
- 2. Incentivize private sector investment in R&D (e.g., R&D tax credit based)
- 3. Increase the amount of public R&D investment secured by research entities and post-secondary institutions in PEI that will positively impact key economic sectors and industry needs



Drive Entrepreneurship to Power 4.) PEI's Economic Success

4.A Grow our entrepreneurial culture

- Champion a coordinated approach to promote and celebrate entrepreneurship in PEI
- Create entrepreneurship pathways for youth opportunity, mapping out programs and supports available and addressing gaps through a defined stakeholder plan

4.B Build an environment that enables entrepreneurial success and growth

- Raise the bar to strengthen and grow PEI's entrepreneurial network, accelerating the impact of entrepreneurial supports and building collaborative communities with entrepreneurial individuals at the centre
- Enhance access to capital and mentoring for PEI start-up and entrepreneurs
- Encourage and support more women, Francophone, Indigenous, and newcomer entrepreneurs who are an important part of PEI's entrepreneurial culture

4.C Strengthen PEI's economy through social enterprise

Increase the capacity of the social enterprise sector through a network model supported by leadership and a strategy that includes creating an enabling policy and regulatory environment and communicating the impact of the sector

5.A Relentlessly communicate PEI's innovative economy

1. Promote PEI's highly collaborative and innovative environment as a major force for economic growth, job creation, and a growing entrepreneurial culture

5.B Be a leader in clean growth and innovation

1. Build a thriving, innovative, export-oriented cleantech sector that will also accelerate PEI's clean growth and climate change priorities
